

National Plan Law, 2020 – 2021 Financial Year

(Pyidaungsu Hluttaw Law No.15/2020)

8th Waxing Day of Wagaung, 1382 M.E.

(26th August, 2020)

Preliminary

The Pyidaungsu Hluttaw hereby enacts this Law in order to implement systematically in accordance with the economic policies of the State laid down for the development of the respective social and economic fields of the State and for the people-centered sustainable development and goals, strategies and processes included in Myanmar Sustainable Development Plan.

Chapter I

Title, Effectiveness and Definition

1. (a) This Law shall be called the National Plan Law, 2020 – 2021 Financial year.
(b) This Law shall come into effect commencing from 1st October, 2020 for 2020 – 2021 financial year.
2. This Law is the National Plan Law for 2020 – 2021 financial year.
3. The following expressions contained in this shall have the meanings given hereunder –
 - (a) **National Plan** means objectives and work plans of the Union Government to what extent of development in these plans is to be within the period specified for the whole, Union Ministry/the sector, or the Region and State of the social and economy of the entire nation. It shall be deemed that the national plan involves comprehensively work development plans such as human resource development plan, plans for industrial zones and special economic zones, industrial development plan, modern agro-industrial development plan, investment development plan, urban and rural development plan, and border area development plan laid down specifically for the sector or the region.
 - (b) **Objective of the plan** means the estimated target for the extent of development within the period specified for the whole economics, the sector and the Region and State.
 - (c) **Financial Year** means the period from 1st October to 30th September.
 - (d) **Year-end Estimate** means the estimation for the combination of implementation in the first six months and the situation for the implementation in the second six months for 2019 – 2020 financial year.
 - (e) **Constant Price** means the price of goods and services in the basic year of 2015-2016 financial year.
 - (f) **Yearly Price** means the prices of goods and services according to the relevant financial year.
 - (g) **Departments and Organizations Concerned** means the Union Level Organizations, Union Ministries, Region or State Governments, Leading Bodies of Self-Administered Division and

Self-Administered Zones and Development Committees concerned which implement the National Plan.

Chapter II

Objectives of the Plan

4. Key objectives of the National Plan for 2020 – 2021 financial year are as follows –
- (a) To increase 6.0% Gross Domestic Product and Service (GDP) according to constant price;
 - (b) The increase rates by sector according to constant prices are –
 - i. to increase 2.2% in the agricultural sector;
 - ii. to increase 3.4% in the livestock and fishery sector;
 - iii. to increase 11.0% in the forestry sector;
 - iv. to increase 0.3% in the energy sector;
 - v. to increase 2.1% in the mineral and mining sector;
 - vi. to increase 7.1% in the industrial sector;
 - vii. to increase 12.7% in the electric power sector;
 - viii. to increase 6.8% in the construction sector;
 - ix. to increase 7.9% in the transport sector;
 - x. to increase 9.1% in the communication sector;
 - xi. to increase 8.6% in the financial sector;
 - xii. to increase 3.8% in the social and administrative sector;
 - xiii. to increase 9.3% in the other service sector;
 - xiv. to increase 7.1% in the trade sector;
 - (c) The increase rates of the Region and State according to constant prices are:
 - i. to increase 4.6% in Kachin State;
 - ii. to increase 5.7% in Kayah State;
 - iii. to increase 5.0% in Kayin State;
 - iv. to increase 4.0% in Chin State;
 - v. to increase 7.2% in Sagaing Region;
 - vi. to increase 3.0% in Taninthayi Region;
 - vii. to increase 6.1% in Bago Region;
 - viii. to increase 7.7% in Magway Region;
 - ix. to increase 4.6% in Mandalay Region;
 - x. to increase 5.6% in Mon State;
 - xi. to increase 4.5% in Rakhine State;
 - xii. to increase 7.4% in Yangon Region;
 - xiii. to increase 4.9% in Shan State;
 - xiv. to increase 4.7% in Ayeyawady Region;
 - xv. to increase 7.2% in Nay Pyi Taw Council Territory;

- (d) to become respectively from 20.6% to 19.8% the inclusive proportion of the agricultural sector, 38.7% to 39.3% of industrial sector, 40.7% to 40.9% of service sector according to the yearly prices of Gross Domestic Product and Service (GDP);
- (e) to raise the total consumption of 90,282.4 billion kyats according to the yearly prices;
- (f) to invest by the proportion of 27.26% from the State sector, 0.01% from cooperative sector, 72.73% from the private sector according to the yearly prices in total investment;
- (g) to export 16,200.0 million United State dollars and import 18,500.0 million United State dollars according to the yearly prices;
- (h) to rise per capita GDP from 2,097,187 kyats to 2,284,970 kyats according to the yearly prices.

Chapter III

Miscellaneous

5. The departments and organizations concerned shall cooperate and implement effectively the objectives of the plan mentioned in Annex (1), (2), (3), (4), (5), (6) and (7). Work plans and directives required to implement the plan objectives may be drawn and carried out in detail by sectors and regions concerned accordingly.
6. In implementing the projects, in the assessment of the projects, the departments and organizations concerned shall proceed the projects which are to be truly beneficial to the interest of the State and its citizens. Provided that, the ineffective projects shall be denied, suspended, and allowed with reduction.
7. It shall, in implementing the National Plan, be carried out by connecting and coordinating with the economic policies laid down by the State. It shall, moreover, be carried out in accordance with the goals, strategies and processes contained in Myanmar Sustainable Development Plan.
8. The departments and organizations concerned shall also earnestly carry out the investment in the human resource development plan which is beneficial to the State and its citizens in the immediate, short-term and long-term and which is the national development plan to be everlasting existence for them.
9. In submitting projects, the departments and organizations concerned shall carry out the projects only if the stipulated requirements and assessments are fulfilled.
10. The projects which reveal national solidarity, union solidarity, internal peace, the projects which provide the rule of law and tranquility and the strategic projects which implement the Myanmar Sustainable Development Plan shall be included in the national plan.
11. The departments and organizations concerned shall draw economic enterprises to be privatized out of the State-owned economic enterprises in the national plan as a plan to be transferred yearly.
12. The work plan to be implemented in 2020 – 2021 financial year shall be included in to the yearly national plan after adding in drawing the 5-year short term plan with the approval of the Union Government after a comprehensive analysis, such as whether it is feasible, economical, beneficial to the citizens, positive contribution to local development and there is environmental impact or not. The Union Government shall have the right to add the special projects carrying out according to the important requirement for the interest of the State and the strategic projects scrutinized and approved

by adding within the planning bank to the yearly national plan although they are not included in the 5-year short term plan.

13. The departments and organizations concerned shall, in respect of estimation, implementation, analysis for the work plans and works that will be carried out by them, coordinate with the respective relevant Hluttaw Representatives, responsible persons and organizations including the Ministry of Planning, Finance and Industry starting from Township-Level fully in accordance with the stipulations. The persons, departments and organizations fail to coordinate shall be taken action effectively in accordance with the existing laws, rules and regulations.
14. The departments and organizations concerned shall, in implementing the work projects to be carried out in the State-owned sector in the national plan investment estimate of 2020 – 2021 financial year issued by this Law and work projects to be carried out in the investment estimate, carry out in accordance with the existing laws, rules, regulations, bylaws, notifications, orders, directives and procedures.
